

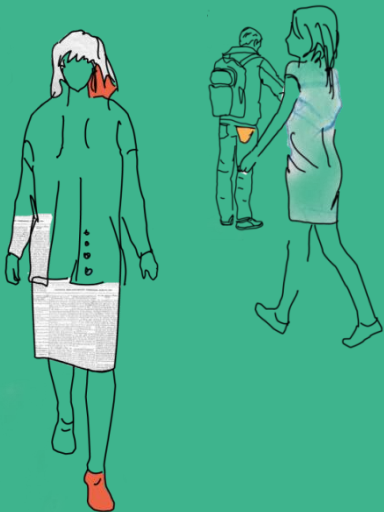

Better Regulation objectives

1. The European Union bigger and more ambitious on big things and more modest on small things;
2. Wider opening policy making to feedback and consultation with citizens and stakeholders - Commission listens to citizens and stakeholders and is open to their feedback;
3. Keeping existing laws under review and fit for purpose;
4. Better impact assessments;
5. Strengthening the evidence base for new policy decisions;
6. Enhancing transparency of the legislative process;
7. Better Regulation – A shared commitment from all EU Institutions.

when the initial idea is presented,

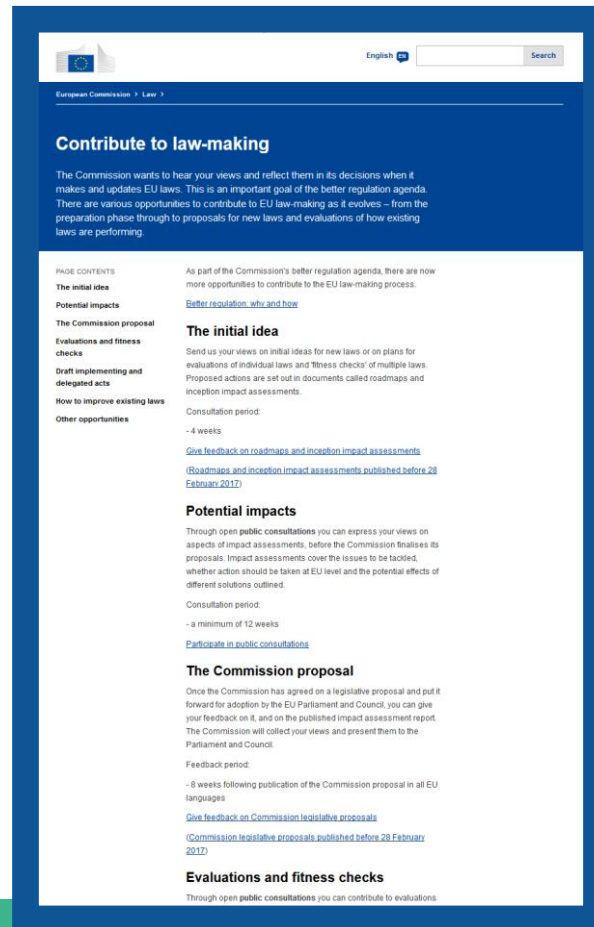
when the Commission prepares a legislative proposal,

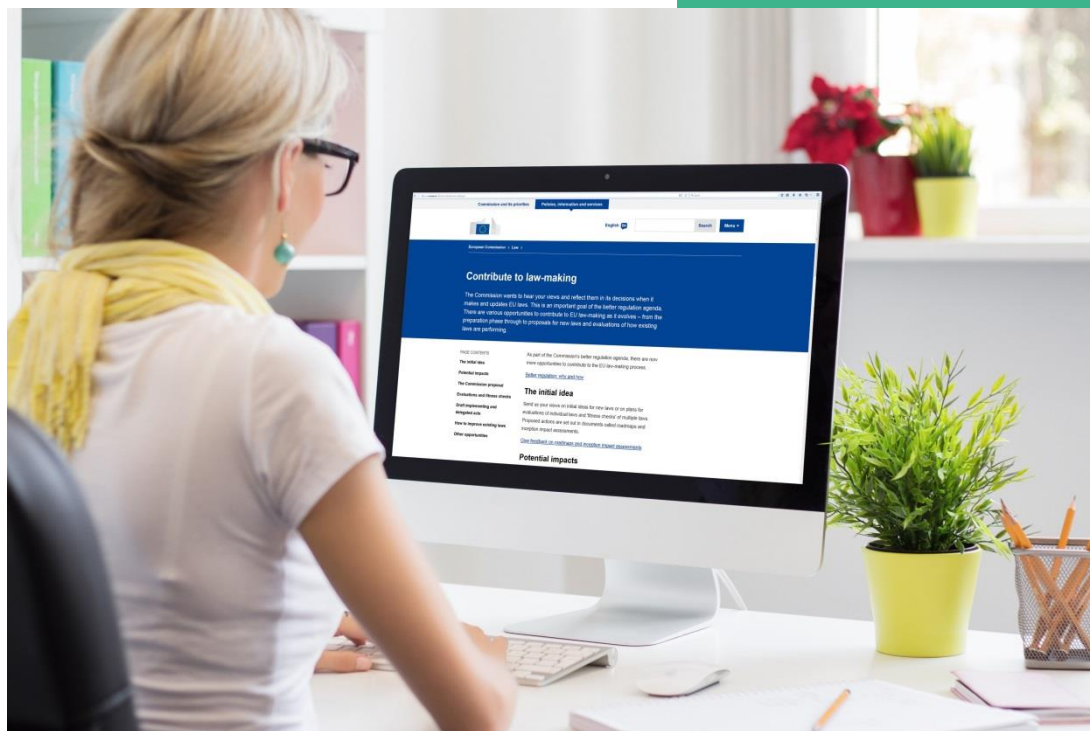
