Context of the conference

Here we go! Europe's work on the post-2020 programme has begun. New elements emerge with each week that passes, mostly in the form of questions.

The White Paper on the future of Europe presents several scenarios, some of which raise questions regarding the Union's priority objectives, such as territorial cohesion or rural-urban balance.

How do we envisage Europe's future policies on rural areas? The Cork 2.0 Declaration provides an overview of stakeholder wishes: how can these interests and objectives be translated into political commitment?

Now is the time to strengthen the dialogue between the European authorities and rural stakeholders, and for exploring in greater depth proposals based on a bottom-up approach.

These are some of the issues being raised at this conference, co-organised by the NAT commission of the European Committee of the Regions and the association Rurality-Environment-Development (RED) in cooperation with the European Countryside Movement.

What are the latest developments in the "rural proofing" proposed in the Cork Declaration? The first part of the seminar will look at how the framework has been implemented in the light of practical experience.

The second part of the seminar will introduce the debate on mobilising some European thematic policies in support of rural areas, discussing territorial cohesion and the positive links between rural and urban poles.

The afternoon session will discuss policies that need to be carried out by the Commission and other European authorities to boost rural areas.

The call launched by R.E.D. for the adoption of a European Rural Agenda as a reference document for cross-cutting post-2020 political and financial commitment on the part of the Union has already received support from a number of associations and institutions (European Committee of the Regions, European Countryside Movement, RUMRA Intergroup of the European Parliament).

The challenge is indeed daunting: responding to the increasing territorial imbalance and degradation of general interest services (health, mobility, safety, high-speed Internet) in rural areas, mobilizing rural potential to the full in line with the EU's objectives,

and regaining people's confidence in the European project. All this calls for innovation and simplification.

It is time to embark on a process of reflection that goes beyond simply adjusting the various sectoral politics. It is no longer enough to continue to propose changes to the structure and measures of the CAP.

Today's situation calls for greater coherence in terms of European policies and resources. Rural stakeholders are asking for a cross-cutting, pan-European policy approach. This is what lies behind the call for a European Rural Agenda. The aim is to maximise the value of all the EU's policies by linking them up, from the CAP to the regional, social and environmental development policies.

This is the over-riding purpose of the debate scheduled for 4 May, one that sets out to be a first step on the path towards a fully-fledged European policy on rural areas.
