COTER External Seminar

Using Cohesion policy instruments to address investment gaps in European regions

With the proposal for a new Multiannual Financial Framework for the years 2021-2027, the European Commission is proposing a new, modern long-term budget, tightly geared to the political priorities of the Union at 27. The proposed budget combines innovative instruments with modernised programmes to deliver efficiently on the Union's priorities and to rise to new challenges. Although the financial envelope for Cohesion policy is proposed to be reduced to reflect the new priorities of a smaller Union, investments still play a key role in the MFF expenditure area. With national public investment still not fully recovered from the economic and financial crisis, Cohesion policy plays a key role in mitigating the impact of the crisis and its positive spill-over effects are not limited to less developed regions only.

The legislative files for cohesion policy post-2020 put forward by the European Commission in May 2018 reflect the need to support investments and to link sound economic governance to Cohesion policy by simplifying the use of the integrated territorial development tools and by setting out a more prominent role of the European Semester's Country-Specific Recommendations (CSRs) within the programming phase.

The European Committee of the Regions has already expressed its views on all Cohesion policy-related legislative proposals by adopting its opinions in October and December 2018, putting forward European cities' and regions' needs and concerns at an early stage in the legislative process. This seminar aims to look at the impact of the EU budget on public investments, as well as real experience in the implementation of integrated territorial development tools. It also aims to give focus to the role of the regions in the programming phase, translating their needs into CSRs, thereby contributing to more effective delivery of Cohesion policy on the ground.

The European Commission has suggested to continue to use several tools for integrated territorial development, including the Community-led local development, Integrated Territorial Investments (ITIs) and other territorial tools supporting initiatives for investments programmed for the ERDF under the "Europe closer to citizens" policy objective. Integrated and comprehensive initiatives at local level are amongst the best tools to carry out small-scale investments at local level.

This session will examine the current state of play in the implementation and the real experience that local and regional authorities have gained in the current programming period. It will also look at an exchange of experiences and best-practices of the use of ITIs and CLLD and consider ways to improve their uptake.

11.50 a.m. Session 3: Translating regional needs into Country-Specific Recommendations

The proposal for the new Common Provisions Regulation suggests strengthening the link between Cohesion policy and the European Semester. In order to support their implementation in the Member States, relevant CSRs should serve as a roadmap for the programming of the funds and design and mid-term review of Cohesion policy programmes. Whilst the negotiations on the legislative package are still underway, Managing Authorities are already engaging in the preparation of their programmes, based on the CSRs to be delivered in 2019. The third session of the seminar will therefore provide an opportunity to review the existing procedures and experience in translating regional needs into CSRs within the upcoming programming procedures, due to start as soon as in 2019.
