Enhancing Resilience of urban ecosystems through green infrastructure

EnRoute Final conference – 14th meeting of the Technical Platform

Conference co-organised by the Committee of the Regions and the European Commission

Background and objectives

EnRoute, a European Parliament Pilot project, provides knowledge of how urban green infrastructure can support urban policy objectives at different stages of planning and for various spatial scales. High quality biodiversity-rich green areas can help policy-making for sustainable cities and contribute to resolving many challenges from air pollution and noise to tackling climate change, heat waves, floods and public health concerns. As cities grow, there is a need to improve the availability, quality and accessibility of urban green spaces. Urban planners across Europe are progressively integrating urban green infrastructure, ecosystem services and nature-based solutions in their urban planning process; but there is a need to scale up these efforts.

EnRoute demonstrates how EU biodiversity and green infrastructure policies and actions are implemented at the local scale in real-life case studies and policy-making processes. The 18 city labs¹ distributed across Europe form the project core. They experienced how science and policy interact on urban green infrastructure development at local level.

This meeting will:

- present the main scientific and policy outcomes of EnRoute;
- provide a forum for policy makers and scientists to exchange ideas of how urban green infrastructure solutions can reconcile urban growth with objectives on biodiversity quality of life and public health, adaptation to climate change, sustainable urban planning natural disaster risk reduction, etc.;
- consider possible next steps, such as how local knowledge co-created by science and policy can be further developed as well as disseminated to improve the quality of European cities, and how can the EU best support this process.
