Purpose of 'extraordinary' General Assembly

On the 18 January 2018, the European Commission published an Environmental Compliance Assurance (ECA) Action Plan to increase compliance with EU environmental legislation. IMPEL is a key partner for DG Environment in helping to implement this plan. The Action Plan also fits, in part, with <u>IMPEL's 'Next Generation' ambition</u> as many of the actions are linked, for example, on building capacity. This General Assembly meeting therefore, will aim to inform our network's contact points, be an opportunity to exchange information and get buy-in from members on an agreed approach going forward.
