CAP budget for Poland 2023-2027: **EUR 25.125 billion**, of which :

- ✓ **EAGF - EUR 17 326 mln**
- ✓ **EAFRD – EUR 7 799 mln**

When drawing up the budget for Pillar I, it was decided to transfer 30 % of EAFRD funds to Pillar I of the CAP as direct payments support farmers' incomes.

Division of the CAP SP for 2023 -2027 (%)

- ✓ **Basic income support for sustainability — direct payments - 47,36.**
- ✓ **Complementary redistributive income support for sustainability - top-up payment - 11,57.**
- ✓ **Complementary income support for young farmers - 1,07.**
- ✓ **Coupled income support - 15.**
- ✓ **Support for selected sectors - 3,07.**
- ✓ **Eco-schemes — 16 schemes to be selected by the farmer -21,93.**

Eco-schemes

Budget: approx. 3.945,06 mld EUR

16 eco-schemes, including:

- **Organic farming - 749,76 mln EUR;**
- **Animal welfare - 667,93 mln EUR;**
- **Mixing of manure on arable land within 12h of application - 545,76 mln EUR;**
- **Extensive use of permanent grassland with stocking density - 535,87 mln EUR;**
- **Simplified cultivation systems - 476,01 mln EUR;**
- **Development and compliance with the fertilisation plan - 232,45 mln EUR;**
- **Winter catch crops/individual seedlings - 207,27 mln EUR;**
- **Differentiated crop structure - 186,24 mln EUR.**

CAP SP Governance

- **Managing Authority - Minister for Agriculture and Rural Development;**
- **Paying Agency — Agency for Restructuring and Modernisation of Agriculture (ARiMR)**
- **Certification Body — Head of the National Revenue Administration;**
- **Competent authority for paying agency accreditation – Minister of Finance;**
- **Implementing bodies – ARiMR, regional governments, and other entities with delegated tasks**

Regional interventions

- **In PL no regional management of the CAP SP interventions are foreseen.**
- **Leader/CLLD approach will be implemented on the regional level by regional authorities**
- **In Wielkopolska Region a multifund-based implementation of local development strategies is planned. They will be co-financed by the ERDF (EUR 20 mln) and the ESF (EUR30 mln).**
