ECRN mission

Give a single voice of the chemical regions' interests

We are engaged in the preparation of the joint positions of chemical regions towards EU Institutions concerning the competitiveness and the sustainable development of the chemical industry, to shape policies at the European level.

Foster interregional cooperation

We organize regular internal and public events, together with the European Institutions – European Commission, European Parliaments, and Committee of the Regions – as well as with regional partners. We provide the speakers that represent the chemical sector for the events organized by different institutions.



Create regional knowledge exchange

We facilitate the transfer of know-how and best practices between regional administrations and regional industrial and research actors

Facilitate the projects' participation

We raise awareness about EU funded projects and initiatives and provide a platform where they easily can find partners. We support cross-border projects, funded by EU Programmes (Horizon 2020, Interreg Europe).









The European Year of Skills puts skills centre-stage. Helping people get the right skills for quality jobs and helping companies, in particular small and medium enterprises, address skills shortages in the EU.

The chemical sector (including pharmaceuticals and rubber and plastics) is the second largest sector in Europe for number of direct jobs (3.4 million people). It contributes 11.9% of EU27 manufacturing employment. The sector generated an even greater number of indirect jobs – up to three times higher than through direct employment. More importantly, salaries are 45% higher and productivity is 67% higher compared to the average in the EU manufacturing sector. These figures clearly indicate that the chemical sector offers a high number of well-remunerated jobs, but it also needs highly-trained and skilled workers to remain competitive globally.

- ➤ 2nd February, 2023 the official launch of the Regional Partnership for Skills in the Chemical Industry

- Become a starting point for in-depth interregional and cross-border cooperation and improve the understanding of the specific regional features and needs

- Support a meaningful dialogue between social partners, education and training providers, R&D institutions and industry
- ➤ Help to speed up the identification of the most vulnerable regions and areas of interest through bringing all relevant partners to the table and surveying their needs
- Stimulate our partners to work on specific tasks and create smaller and targeted working groups that can lead to the concrete project

- Improving cooperation between EU and regional levels


