

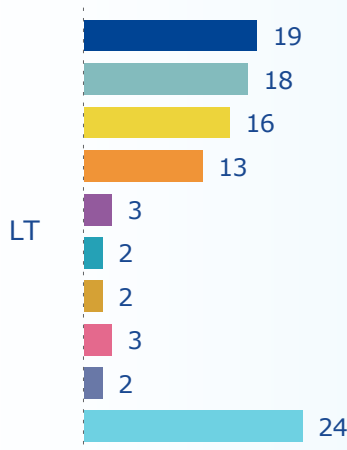

sd2 Which political party do you represent? (%)



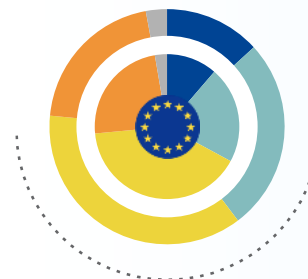

q1 In general, do you agree or disagree that regions, cities and villages have enough influence on the future of the European Union? (%)



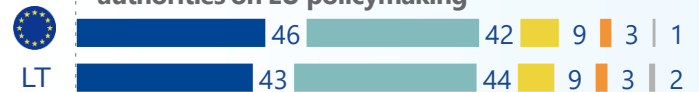

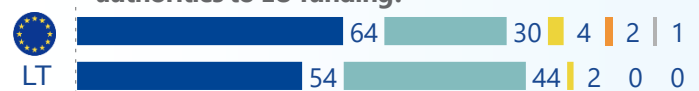

Improve the access of regions and local authorities to EU funding?



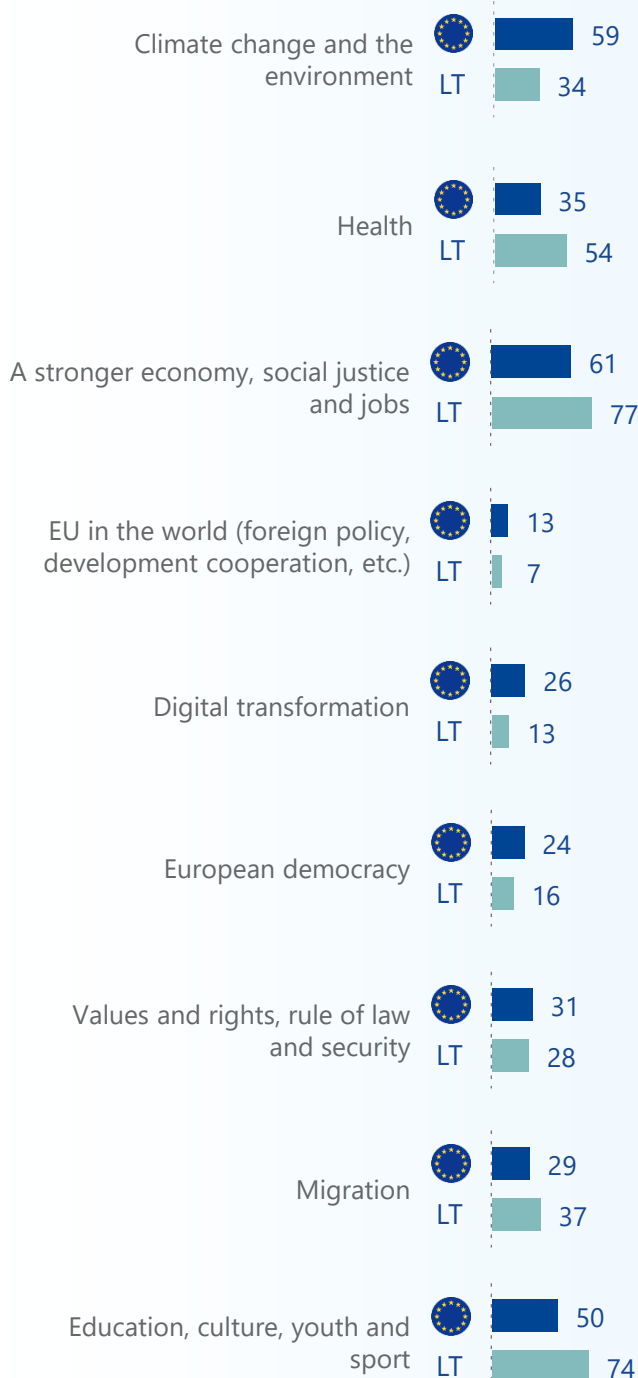

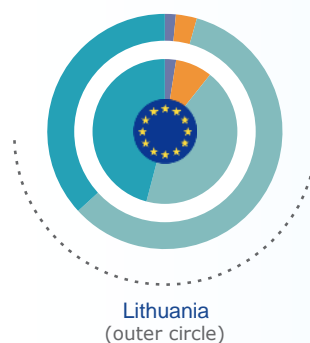
