## Ukraine

In Ukraine the registration of union of Euroregional cooperation is carried out on the general principles of the relative legal entities' registration depending on its location in the organizational

and legal form of a non-business partnership, which is not intended to obtain income (profit) for its further distribution among the founders (participants), members, employees (other than pay for their work, accrual of a single social contribution), members of management and other related persons.

Such registration is carried out by the executive bodies of rural and city councils, Kyiv and Sevastopol cities', districts', districts' in the cities of Kyiv and Sevastopol state administrations, notaries.

The Ministry of Justice of Ukraine is the main body in the system of central bodies of executive power, which provides for the formation and implementation of state policy, in particular, in the field of state registration of legal entities, public entities that do not have the status of legal entities, and individuals persons - entrepreneurs.
